    - Brian suggested a conflict of interest statement to be incorporated as part of the bylaws. Brian can share this
    - Brad suggests we revise the conflict of interest statement in the interim
    - Create a 2020 conflict of interest statement
    - Kristi- suggested incorporating board expectation (x2 documents), conflict of interest, etc.
    - Term limits: Brad, I understand the desire to have fresh blood, but also seems limiting. (would need to be changed in the bylaws)
    - Update conflict of interest along with expectations (executive committee)
  - TBID
    - TBID will required By-Law adjustment

- a. 202 Landscape
  - Fireworks
    - Zambeli's out for fireworks (firm)
    - PyroSpectacular- looks like a good fit in terms of meeting local requirements. They have their own cleaners, divers, drivers, etc. (does Incline, Snowfest, Donner, Private shows in Incline, etc. - well respected and local)

- Working on final proposal with them -
  - Price point is 33K
  - Budgeted at 29K
  - BMP could increase this budget further
- 14 day notice cancellation.

## 7. Partner Updates:

**a.** NTPUD, NLTRA, TMA

15 min (4:55pm-5:10pm)

- NLTRA:
  - Working on TBID for a year
  - Had hoped to go to vote before Chifstmas- didn't happen because of relative complicated nature of this TBID compared to others that the consultant has worked on (Civitas)
  - Two criteria for IDining business and writing management plan
    - business ha to substantially benefit from tourism
    - Funds from TBID have to be used to promote tourism
  - Of the 1800 businesses- we have IDed 632
  - Overwhelming support from local businesses, but don't have petitioned support from some of the "big players" (Vail)
  - Do not yet have Vail's support
  - Civitas is concerned about potential protests/legal suits. Have gone through the management plan with a fine tooth comb
  - In order to move forward the Resort Association board has to approve the management plan. It then needs to go to county council which will approve for compliance with TBID Law
  - Questions related to the plan elevated by the principal at Civitas:
    - Business and advocacy budget item verbiage around financial support for the operations of TCDA and NTBA equal to the total amount of Placer County current contract amounts. This language is problematic for reasons related to the charter of the two organizations and their budgets (not all funding used for tourism) - Language being proposed is: "financial support for the tourism based activity provided by TCDA and NTBA"



- Could have a side agreement that wouldn't be in the management plan for a greater level of commitment from the Resort association
- NTBA has two choices:
  - Language is adequate with the addition of the side agreement (would require Resort Association Board approval)
  - ii. Go back to place county and city and request the continuation of grant funding from pacer county directly.
- Seeking a final version of the management plan for resort association approval this week
- Greg: Would we be required to manipulate our budget to ID touring related items Rob: might be helpful, but not required
- Alyssa: Feels like 90 percent of our work is tourism based. Event coordinator should qualify.
- Greg: Were there specific items that civitas was concerned about Rob: too soon to tell
- Alyssa: Our contract with county with TOT is set up the same way (requirements for tourism). Unclear why we can't have a similar contract arrangement
- Rob: we agree that the vast majority are tourism related. Believe that the board will be supportive of a separate agreement. Also spoke with Cindy- who felt similarly that NTBA's activities are tourism related
- BOS: Can't guarantee money if the TBID fails in five years, though it's their intention
- Greg: out assumption is that the vast majority of our budget it tourism based. If Civitas disagrees - we would like that feedback very quickly. Rob will forward budget to them today.
- Charlie: can civitas provide clarification on their concerns. Suppose to directly benefit the assessed businesses. Could be concerned that some of work is supporting businesses that are not assessed by the TBID. Could 60% of funding be rescinded because many of the businesses we support are not assessed.



- 130K County amount and membership dues (amount that the TBID would replace). This is 40ish% of the NTBA budget
- Rob will send agreement to Alyssa
- Brad, NTPUD
  - Rate increases in effect. All billing will be in arrears. February bill will have new rates
  - Three week run of family movie night will start next week. Doors at 5, movie at 6, popcorn and snack for purchase
    - New Aladin
    - Finding Nemo
    - Neverending Story
  - Feedback: change the photo on the facebook event
- Jessica; TTMA
  - Increase in ridership due to free service
  - Still struggling to find/hire drivers affecting the 30 minute service
  - Park and ride service started on December 28th. Need more PR on this.
    - Biltomore in CB, Airport, TTUSD Central Office, Tahoe City
