- a. The Board authorizes the Executive Committee (EC) to begin the work necessary to dissolve the legal entity known as the North Tahoe Business Association, a CA Non Profit.
- b. The Board acknowledges and thanks the NTBA Task Force for its work. The board accepts the task force's recommendation as presented at its last board meeting to begin work with the NTCA. The board recognizes that a group that includes other community stakeholders is ongoing and authorizes the EC to incorporate those agreed-upon changes.

Heidi opened the discussion by thanking the board and staff for trying valiantly to save the NTBA over these past 10 months. The board met in closed session last month and recommended dissolving the organization due to the overwhelming debt and insufficient resources to continue operations. She then thanked the Task Force for its work to help us sort through next steps. Alex added we should create some sort of proclamation about our situation, thanking our past supporters and how we're moving forward. We also need to do a formal statement to the public about the wind down. Everyone who has a connection to NTBA should be aware. Kerry noted that he and Darcy are meeting twice a week with Adam at NTCA and have started a list of all the items that need to transition.

Lew then made a motion to begin dissolution of the NTBA in coordination with the NTCA. Sean seconded. All approved.

Lew made the motion to approve 6b, Alex seconded and all approved.

7. Community Events and Collaborations (Darcy & Kerry) 30 min (3:45-4:15pm)

a. Snowfest Parade – Kerry said it went very smoothly. Great day and turnout. Volunteers did sign up at the last minute, which helped ensure it was successful. Darcy added thanks to Sean for being the emcee at the parade.

Alex noted that Tahoe City's change to do a festival was expected to be challenging and instead, the merchants seem to really appreciate the change as people tended to hang out more. It seemed they stayed around and spent more time at the local businesses and enjoyed interacting with the floats. Maybe look at a hybrid model next year for Kings Beach. The board spent some time discussing how to grow the Parade and make it a destination event.

b. Music on the Beach

i. Action Item: Approve MOTB Budget

Kerry shared the draft budget and noted 10 of 11 band contracts have been signed. We will need to figure out how to manage the contracts given the current situation. Adam shared that their legal counsel is looking at sending all contracts with bands an updated contract from NTCA so Music on the Beach still happens. Sean wants to get rid of plastic cups, and transition

to disposable aluminum cups. Heidi suggested compostable plastic cups since pouring beer into the steel mugs/aluminum ones is challenging. Alex said approving a budget given the current situation is challenging for us as a board since this should have been done months prior and before band contracts were initiated.

Alex moved with an amended motion. "Recognizing the NTBA will not be able to execute this budget, we approve this budget and encourage NTCA to consider using this budget for planning purposes as they support the event series this summer." Heidi seconded – all approved.

c. Clean Up Days – Kerry noted normally we'd be planning for these – the first Saturday in June and last Saturday in September. Typical event is on June 7 9am to 11am – registration table at Sierra Community House, handout trash bags and gloves and give volunteers an area to go. Then a crew picks up the bags and brings them to the dump. Generally, there are about 75-100 people – often weather dependent. Darcy added there is potential with Clean up days to engage the community and business members to provide coffee, live music, and make it a fun event. Invite the Be-bot robots.
